

MAX POWER RIDER

MAX POWER will provide:

- MAX POWER strolling show
- Mini Monster Truck Drive around

The Event will provide (at event's whole cost):

- One 21 year old or older security person for each walk/drive around
- Area to park trailer 45ft deep x 25 ft wide
- Parking for Semi
- 24 hour electricity with (1) 50 amp outlets for trailer (we have tails available for hardwire if permanent ones aren't available). The 50 amp plug is 3 straight and one round (standard camper plug) Water for trailer.
- One non-smoking double occupancy hotel room beginning the day prior to the event and check out the day following the event.

General:

- There shall be no deductions for performance cancellations due to inclement weather. The decision to cancel a show based upon inclement weather will be decided solely by Max Power based on safety of performer.
- Events that fall within a state that has an out of state entertainer tax must adjust the compensation listed on this contract to cover the amount of said tax prior to signing this contract so that the check being cut to Max Power will be in the amount of the sale price.
- Any local or state permits required for the Max Power show shall be ordered and paid for in advance of the event by the event.
- Any motorized vehicle permit (golf cart, Segway, scooter) required by the event will be provided at no extra charge to Max Power.
- Max Power will defend, and hold harmless the Agency/Operator from any costs or other liabilities arising from bodily injury or liability do to property damage arising out of negligence, or occasioned by any action or in action by Max Power or its staff while performing or on the grounds.
- Max Power show schedule will take place within an eight hour window from the first show start time to the last show start time.

- This is a non-cancelable contract. Failure on the part of either party signing this contract to fulfill said contract shall make the party failing to do so liable for amount of the contract. Should the entertainer or the event be unable to fulfill this engagement by circumstances which are beyond their control, such as acts of God, strike, fire, epidemic, accident, transportation delays, sickness, governmental action or any other causes of like or different nature, they shall not be in breach of contract.
- Max Power certificate of insurance with the liability limit of not less than one million dollars per
 occurrence for the duration of the event, including the period of time from set-up to tear down. If the
 event wishes to be named as an additional insured, please notify Max Power at the time of contract
 signing.
- Any and all litigations arising out of this agreement and or the performance shall be brought in the courts, in Delaware County, Iowa, and not elsewhere. The parties further agree that should it become necessary to consult an attorney due to a breach of this agreement, then such cost will be considered as recoverable damages

In addition to the compensation listed above, the following considerations will be provided as indicated: Event Admission: enough passes per day for performers and support staff. Our support staff numbers may change throughout the year. We will give you the number of staff upon arrival (up to 4).

Parking: Up to 2 vehicle passes per day



NOTE: THIS IS A SAMPLE LAYOUT. EVERY LOCATION WILL BE EVALUATED AND A PROPER LAYOUT WILL BE DECIDED UPON ARRIVAL



Semi space needed is 45 ft long x 20 ft wide

Trailer space needed is 45 ft long x 20 ft wide (leaves room to park Nitro between shows and room for lift gate to go down and robot to walk out)

If the two are parked as shown 90 ft long x 20 ft wide

If they are parked side by side 45 ft long x 35 ft wide
